
- 1. Application Fee Alvenia vill wive the application fee for students who apply at Alvenia puscent to this Agreement.

# Revision Reneval and Termination of this Agreement

The Provost at Alvenia University and the Vice President of Academic Affairs at Delavare County CommityCollegeortheirobsignes, acresponsible for identifying and communicating to each other; charges in the policies or requirements of their respective institutions that affect this Agreement.

Modifications to the terms and conditions of this Agreement may only be made by written agreement of the parties. Until such modification by mutual written agreement, the then current terms of the Agreement shall remain in effect

This Agreement will be ineffect as of the date of its signing for students entering Alvenia on or after Spring 2024, and will continue ineffect for five (5) years unless otherwise modified or terminated in accordance with this Agreement. Either institution may terminate this Agreement at any time by written notice at least one year in advance of the effective date of termination. Should this Agreement be terminated, it is understood that students already accepted to Alvennia through the effective date of termination will continue to receive the benefits articulated in this Agreement.

Provided that all parties execute a copy of this Agreement, this Agreement may be executed in conterparts, each of which shall constitute an original, and all of which together shall constitute one and the same channert. This Agreement may be executed by the parties and transmitted by facsimile or electronic transmission, and, if so executed and transmitted, shall be effective as if the parties had delivered an executed original of this Agreement. The villingness of both institutions to enter this Agreement in order to facilitate the transfer of students from DCCC into Alvenia, and to expand their apportunities for academic success there, is indicated by the following signatures

## Prelicensure BSN Guidelines

Students visiting to transfer to Alvenia University firm and the institution of higher education must meet the general achiesion equivements of Alvenia and have aminimm cumulative GPA of 30 A gade of C+ of higher is expected for transferscience courses. Students may not have repeated any required science courses and ethen one time for a passing grade and may repeat no more than the etotal required science courses at any/all institutions they have attended, induding Alvenia

Transfersturents who have completed at least 30 cecits of college level work, including the prescribed science couses for the first year; may be digible to transfer at the sophomore level. To be digible for achies ion to and placement in the rusing program at the sophomore level, applicants must complete all general achies ion requirements, and

- Must have a GPA of at least a 30 with considerations given to individual causes. Science cause grades of C+ or higher are ordinarily required for achiesion. Grades and ordits from developmental causes are not considered.
- Not have repeated any required science courses at any/all previous institutions they have attended
- Demonstrate successful complete of these of four of the required sciences (Anatomy and Physiology 1, Anatomy and Physiology 2, Microbiology, Chemistry, each including alab), two of which must be Anatomy and Physiology 1 & 2
